League Management Committee Meeting (LMC) on 10th July 2024

Chaired by David Beater, League Coordinator.

1) Introduction DB thanked the League Committee for their contributions for assisting with advice to league structures and decisions over issues as they arose this summer.

2) Summary of Rule Updates:

At the Spring Meeting held on 24th March 2024 eight clubs were represented and some minor adaptations to the rules were made. These were circulated to clubs with amendments in blue prior to the AGM. We hope most have seen and read these changes.

It was decided at the Spring meeting we would form a league committee and we have since had our first meeting held on the 29th May. The committee has contributed to a number of league issues over the summer months.

3H ES membership. We endeavour for all clubs to have ES membership and all individual county league players as paid up members too. We will need to do well with overall ES membership numbers to achieve the enhanced rebate. A discussion took place on the cost for individual players to play in the leagues which has been set at £15 for the county. It was suggested whilst there is a rule for individual league players to be fully paid up and signed up ES members they would not be penalised for the coming winter league and we will monitor how the individual membership take up goes. In the meantime we ask clubs to support the county in encouraging individuals to join up for Dorset Leagues in light of the benefits of the enhanced rebate.

8 (b) Play Ups now allowing 5 play ups not 3. The aim is to enable captains to have more available players from Lower teams. Concerns were raised about allowing too many 'play ups' because all it relies on sharing players between teams and does not achieve full commitment in each team. Captains, however, have struggled to achieve full team turnout in recent months and it was felt if we give captains more available players we hope to achieve more matches played on the original agreed date without the need for rearranging.

Rearranging fixtures Request/reminder to captains If you do need to rearrange a match please email the League coordinator and opposition captain at the same time, giving the minimum due notice (4 days). That way we can get the new date on the system as soon as possible and helps with the smooth running of the leagues.

9(a) Players cannot be re registered for a different club. An exception may be allowed should the league committee agree. E.g a player not getting enough matches.

9(e) Teams withdrawing from the league. If they want to rejoin to a lower division this is usually not allowed. However, providing the league coordinator and committee are agreed on the levels of individual players an exception could be made.

10e) Clubs with more than one team in the same division (currently only effects West Hants and Bournemouth) should play each other first in each half of the season. However, since sometimes matches are rearranged and move we have made an allowance to get this played in

the first half of period 1, or the first half of the period 2. As long as the matches are **not played** at the end of each half this should be acceptable.

Unregistered players. Occasionally clubs simply forget to register a regular team player and the offending player is only penalised by forfeiting that string. In most cases players who are unregistered go ahead and play a match unknowingly in their rightful position and have no idea they are unregistered until the captain puts in the results after the match, then realises the player is not listed in the drop down.

This rule will remain in place for the winter leagues 2024/5 and further discussion will take place at the League Committee this autumn as to whether it is necessary to penalise all lower rubber.

3). Four Person Teams. The county committee was asked to consider a vote on 4 person squash teams or to keep 5. We recapped on some of the advantages of the alternative options.

Advantages of 4:

- 1) Less players to get a full team
- 2) Easier for transport
- 3) Earlier finish, earlier to bed for players and club operators.
- 4) Count-backs can be fun!

Advantages of 5:

- 1) Suit purists
- 2) 5 players can create a great interest in the final game if the scores level at 2-2
- 3) More people playing in a team, more getting team experience including youngsters
- 4) If we give in to 4 players it might then be 3 and then fold like the ladies.

Smaller clubs might benefit more with 4 person teams as they have a smaller pool of players to get 5 players committed for the match. Concerns were raised if we were to move to 4 person we might never go back to 5's. It was suggested 5 person teams create a better atmosphere with more opportunity for supporting your own team (4 player teams requires two to referees/markers while the other two players are on court)

Ten clubs voted (via email in advance of the meeting or present at the meeting).

Result:

Division 1:5 player teams won by 6 votes to 4Division 2 & 3:5 player teams won by 8 votes to 2

4) Winter Leagues Structure Handout. A discussion took place on the draft handout. Confirmation of team commitment was needed from a small handful of clubs/teams and we await feedback. Given the small size of division 2 squash it was suggested whether we could bring a team up from div 3 (Two Riversmeet unable to field 2 teams in Div 2 because of sharing players issue, Bournemouth 3 possibly not strong enough to move up from division 3?). Three rounds of fixtures (15 matches) was suggested by Andy Corben to achieve more fixtures if we only have 6 teams.

Winter Cup will be replaced by a Spring Cup will be held after the winter leagues have finished, so end of March, April and May (avoiding Easter) with the aim of having no overlap with the leagues and knockout. This means it will be clear if players have played twice for the club to qualify for the knockout cup. We have the added advantage of seeding teams from the league too. Players must play two matches (not three) for their club before qualifying for the cup.

LEAGUE ENTRY FEES for winter 2024/5 Is set at £65 per team.

5) KARAKAL BALLS. These are WSF approved and the committee have purchased balls for teams to trial. Karakal have offered a sponsorship partnership for us to consider. These balls can be trialled over the course of the season and we welcome feedback.

SUMMER CUP FINALS DAY is booked at Two Riversmeet on Saturday 7th September. Draft schedule was handed out and will be advertised shortly.
